However this exclusion shall not apply to any **Claim** brought by or on behalf of any shareholder of the **Company** against an **Insured Person** in connection with the loss and/or damage suffered by the said shareholder or the **Company** in respect of such actual or alleged acts or omissions.

The title and any headings in this endorsement are solely for convenience and form no part of the terms and conditions of coverage.
